1. I understand that Good Karma Dog Center LLC is an open play environment and because of this there are inherent risks, which even when monitored, may result in the following:
 - A. Transfer of a communicable illness such as but not limited to, "Kennel Cough", also known as Bordatella virus, "Puppy Warts" also known as canine papilloma virus or parasites.
 - B. Common injuries, such as broken nails, sore pads, puncture wounds, abrasions and cuts, particularly in shorter coated breeds or any other injuries to my dog (s), including but not limited to permanent physical disability or death.
 - C. Behavior problems.

I further understand that there are other inherent and potential risks involved with interactions between humans and dogs as well as between dogs and other dogs which may result in property damage or bodily injury not limited to A, B, and C as set out above. I fully accept and assume all risks and responsibility for all risks including, without limitation all losses, costs and damages incurred as a result of my or my dogs participation in daycare including any veterinarian expenses incurred on behalf of my dog(s).

2. If health or behavioral problems develop in my dog(s), that these will be treated as deemed best by the staff of Good Karma Dog Center LLC within their sole discretion and I assume full financial responsibility for any and all expenses involved including but not limited to veterinary care.
3. Good Karma Dog Center LLC and their staff will not be liable for any health or behavioral problems that develop in my dog(s) and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at Good Karma Dog Center LLC.
4. I am solely responsible for any harm, including to any other dog(s), to the employees, invitees, interns or staff of Good Karma Dog Center LLC, or to the equipment, physical plant, or other property of Good Karma Dog Center LLC, caused by my dog(s) while my dog(s) is/are attending Good Karma Dog Center LLC.
5. I agree that Good Karma Dog Center LLC shall not be responsible or liable for any lost, stolen or damaged personal property belonging to me.
6. Photographs, or other graphic, sound or other images, likeness, recordings etc may be made of my dog(s) and that such may be used for any purpose without compensation, and I release to Good Karma Dog Center LLC all rights that I may possess or claim to such image, likeness, recording etc.

7. Payment is expected when services are rendered. If any amounts remain due after thirty days, Good Karma Dog Center LLC reserves the right to impose interest at the rate of 1.5% per month until paid. If Good Karma Dog Center pursues collection proceedings, I will pay reasonable attorney fees and costs of collection.
8. Cancellation policy. I understand that I will be charged for a full day of daycare if I fail to cancel my daycare reservation twenty-four (24) hours in advance.
9. I have disclosed and shall continue to disclose on an on going basis, any and all medical or other conditions including but not limited to personality concerns or behaviors that may affect, limit or prevent my dog(s) ability to participate in play time or otherwise attend Good Karma Dog Center LLC.
10. We impose a \$10.00 late fee for dogs picked up after 6:00 pm. If your dog is not picked up by 6:30 pm we will assume that you are boarding and will impose at \$20.00 overnight charge.
11. I have received, read, understood and agree to the terms outlines in the Good Karma Dog Center LLC document, " Dog Daycare Guidelines", which are made part of this agreement, and I have read and understood all terms of this agreement and fully understood the terms of this agreement and understand that I have given up substantial rights by signing it and have signed it freely and voluntarily without any inducement, assurance or guarantee and intend it to be complete and unconditional release of all liability to the greatest extent permitted by law and agree that if any portion of this agreement is held to be invalid or unenforceable that the remainder of this agreement shall remain in full force and effect. I agree that it is intended that all terms of this agreement control despite any particular statute or laws that would otherwise protect me or my dog(s).
